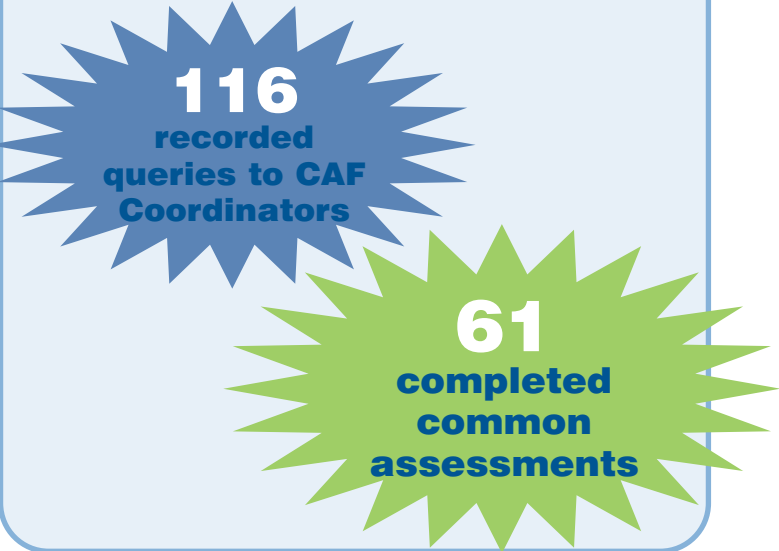

Benefits of CAF

Bringing information together – By gaining a full picture of the child's situation it became apparent that there were more complex issues requiring specialist support. This is an example of where a common assessment helped to gather all information from different sources and provided clarity about the child's needs. The common assessment was then used to inform a request for a specialist service.

Parent Perspective:
"its good to know the help is about what I need, not what people think I need or should do"

Practitioner perspective:
"Great Idea, well put together and the support is there. Everyone is aware of what's going on" (Early Years worker).





Top Tips from Practitioners:

Below are some helpful hints from Practitioners who have already completed common assessments in Worcestershire:

“When booking a coordinated support meeting which includes staff from schools, aim to book the meeting for after 4pm”

Headteacher

“Stay solution focused in the coordinated support meeting – This enables an appropriate plan to be drawn up”

Home Liaison Support Officer

“When arranging the coordinated support meeting, give a number of dates to begin with and go with the majority, look at the key people who need to attend”

Headteacher

“Keep the coordinated support meeting small and focused”

Community Support Officer

“Ask your CAF Coordinator for support, even if it’s just for reassurance – it helps!”

Multi Agency Referral Form (MARF).

Children’s Social Care are keen to enable swift and easy referrals where a child may be in need or in particular, where there are safeguarding concerns.

The existing Multi-Agency Referral Form (MARF) has been revised and is now in line with the Common Assessment Framework (CAF).

To avoid having to duplicate work, the consent form on the MARF has been separated from the main assessment form, and can be attached to a Common Assessment (if consent is required) to support the referral to Children's Social Care.

Worcestershire – an early adopter for the National Ecaf system!!

Worcestershire recently put in a bid to the Department of Children, Schools and Families (DCSF) with other Authorities in the West Midlands to become an 'early adopter' of the National Ecaf system - we were successful! This will give Worcestershire a chance to test and shape the new system, which when ready, will enable practitioners to share common assessment information quickly and securely via an electronic process.
